Statutory Responses to Domestic Minor Sex

| Identification | Initial Custody | Process Following Initial Custody |

| Abused, Neglected or Dependent Child | Authority for Initial Custody: Removal is necessary to prevent immediate or threatened physical or emotional harm Child is endangered by conduct, conditions or surroundings | → Where is child referred after initial custody? Notice must be given to the parents and to the court |
| | Placement: - Parents preferred (possible protective orders) - Shelter care NOTE: No authority to place in detention. | When and how does court assume jurisdiction? - Any person with knowledge may file a sworn complaint - If child is taken into custody, complaint must be filed before the end of the next day |
| Unruly or Runaway Child | ► Authority for Initial Custody: By law enforcement or an officer of the court when a complaint has been filed alleging child to be unruly or if there are reasonable grounds to believe that child has run away | → Where is child referred after initial custody? Notice must be given to the parents and to the court |
| | Placement: - Release to parents - Detention or shelter care if needed to protect the child or others or to keep child from disappearing | When and how does court assume jurisdiction? - Any person with knowledge may file a sworn complaint - If child is taken into custody, complaint must be filed before the end of the next day |
| Identified as Delinquent | Authority for Initial Custody: By law enforcement under: The laws of arrest Reasonable grounds to believe child committed a delinquent act | → Where is child referred after initial custody? Notice must be given to the parents and to the court. Intake or other authorized officer begins investigation |
| | Placement: - Release to parents -Detention/shelter care - Short-term in adult facility for 3 hours if misdemeanor-level offense, 6 if higher | When and how does court assume jurisdiction? Upon an information filed or an indictment |
